### State and Counties to Implement Stage II Fire Restrictions

Effective: July 27, 2017

Missoula, MT — Stage II fire restrictions will go into effect at 12:01 AM on Thursday, July 27<sup>th</sup> across southwest Montana. State, county, and private jurisdictions implementing restrictions:

- MT-DNRC Southwestern Land Office/State Land and private classified 'Forested' Lands within \*Granite, Lake, Missoula, Mineral, Ravalli, Sanders, and \*\*Powell County
- Montana Fish Wildlife and Parks, Region 1&2 within Missoula Restrictions Area
- Counties: Granite, Lake, Missoula, Mineral, Ravalli, and Sanders
- The city of Missoula has agreed to join the federal, state, and county officials into Stage II restrictions on its open spaces, conservation lands, and non-irrigated park lands.

*\*Granite County lands north of I-90.*

*\*\*Powell County lands north of I-90. Powell County is **not** implementing Stage II Restrictions on private lands that are not classified 'Forested.'*

The purpose of fire restrictions is to reduce the risk of human-caused fires during periods of extreme fire danger. Campfires will be prohibited when the order takes effect. Critical fire conditions of dry fuels, hot temperatures, low humidity, and high winds are expected to continue. Current initial attack activity has local IA resources at critical draw-down levels. An additional impact to local resources are the continuing efforts to support large fires within the geographic area.

Under Stage II the Following Acts are prohibited:

1. Building maintaining, attending, or using a fire or campfire.
2. Smoking, except within an enclosed vehicle or building, a developed recreation site or while stopped in an area at least three feet in diameter that is barren or cleared of all flammable materials.
3. The following acts are prohibited from 1:00 p.m. to 1:00 a.m. except as otherwise described in this Order below:
  - a. Operating any internal combustion engine.
  - b. Welding, or operating acetylene or other torch with open flame.
  - c. Using an explosive.

Also, a one-hour foot patrol in the work area is required following the cessation of all activities as identified in #3 above.

4. Operating motorized vehicles off designated roads and trails.

Exemptions to Stage II Restrictions

1. Persons with a written permit specifically authorizing the otherwise prohibited act.
2. Persons using a device solely fueled by liquid petroleum or LPG fuels that can be turned on and off. Such devices can only be used in an area that is barren or cleared of all overhead and surrounding flammable material within three feet of the device.
3. Operating generators with an approved spark arresting device within an enclosed vehicle or building or in an area that is barren or cleared of all overhead and surrounding flammable materials within three feet of the generator.
4. Operating motorized vehicles on designated roads and trails.
5. Emergency repair of public utilities and railroads as per attached conditions.
6. Persons conducting activities in those designated areas where the activity is specifically authorized by written posted notice.
7. Any Federal, State, or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
8. All land within a city boundary is exempted unless otherwise prohibited by an order or resolution.
9. Other exemptions unique to each agency/tribe.
